



Regional Director Nominating Timeline

Monday, June 23, 2025	2025 Annual Meeting
Assembling of Nominating Committee	Members accepting appointment to the Nominating Committee shall not be eligible to be a candidate for election as an Officer or Director for the ensuing year. The immediate Past President shall propose a Nominating Committee of which the Immediate Past President shall be chairperson and on which all Regions shall have representation. Other than the Immediate Past President, members of the Nominating Committee may not be current Directors or Chapter Officers, but at least two shall have served on the Chapter Board of Directors within the past eight (8) years.
Regional Director Candidate Timeline	
Friday, February 28, 2025	Within ninety (90) days after the Annual Meeting each year, the Board will prepare and post to the Chapter’s web site, the criteria for Director candidates that will be used by the Nominating Committee to nominate candidates for the following year’s election, along with such forms, timelines and other materials as are relevant to the nomination and election of the Regional Directors (collectively, the “Nominating Timeline”).
	Directors will be elected within their own Regions prior to the Chapter Annual Meeting according to that year’s Nominating Timeline. The Nominating Timeline will include deadlines for each of the following to occur in order to allow each Region to complete its election:
On or before March 10, 2025	The Nominating Committee will inquire from each current Director their intentions on serving an additional term or balance of their current elected term. Once the slate is determined by the Nominating Committee, one-year terms may be an option for election of a successor to serve the balance of an un-expired elected term of a retiring Director.
On or before March 17, 2025	The standing Regional Directors in each Region shall notify the members of their Region of the eligibility requirements for serving as a Regional Director and solicit prospective candidates.
On or before April 1, 2025	Each Regional Director shall submit to the Nominating Committee Chair a list of eligible candidates to serve as Director for their Region.
On or before Monday, April 28, 2025	The Nominating Committee Chair will convene the Nominating Committee to review and interview the prospective candidates. In the event a Director in office chooses to run for another two-year term, the Director will be included in the Nominating Committee review. The Nominating Committee will qualify the candidates for each Region and facilitate elections where a new Director must be elected. The candidate(s) elected in each Region will be the Director(s) for the next respective term. If only one (1) candidate is eligible, qualified or put forth, that candidate shall be deemed elected by acclamation.
Friday, May 23, 2025	Final ballots containing the Nominating Committee slate and any qualified candidates submitted by successful petition will be distributed to all members who are eligible to vote at least thirty (30) days prior to the Annual Meeting.
Monday, June 9, 2025	The Nominating Committee shall count and report to the membership the result of the election. Improper ballots, i.e., absence of member identification on return envelope, will void the ballot.
Monday, June 23, 2025	Director(s) shall be elected by their respective Regions and installed at the Annual Meeting according to the Nominating Timeline posted to the Chapter’s web site.
