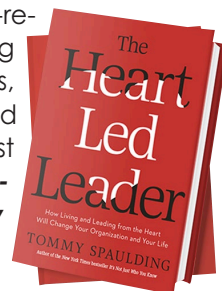

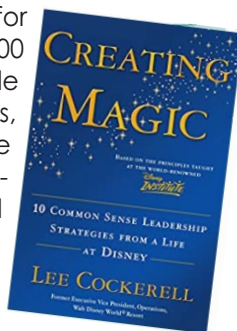

Walt Rakowich

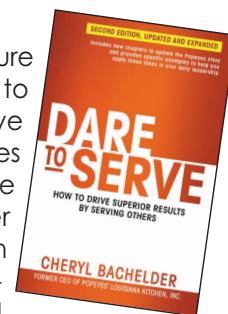

Audiences will learn valuable life lessons and be inspired to reflect on their choices and decisions.



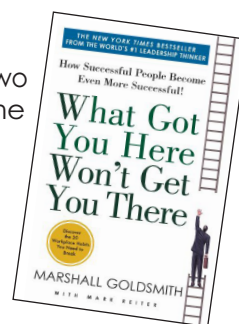
