# Job Summary:

Responsible for all aspects of the club including its activities and the relationships with the Board of Governors, members, guests, employees, community, government and industry. Administer the clubs' policies as defined by the Board of Governors. Develop operating policies and procedures and direct the work of all department managers. Implement and monitor the budget, monitors the quality of the clubs' product and services, and ensure maximum member and guest satisfaction. Secure and protect the clubs' assets, including facilities and equipment.
