Job Title: Controller

Job Summary: The Controller is responsible for overseeing all financial operations within the club, ensuring accurate accounting, financial reporting, and budgeting. Evaluates operating results in terms of costs, budgets, policies of operation, trends, and increased profit possibilities. The Controller will work closely with department heads and external auditors to maintain the club's financial health, while also implementing best practices for financial management.

Key Responsibilities:

- Verifies that all procedures concerning the 401K program available to the employees are followed and that the club properly maintains all records.

Qualifications:

- Bachelor's degree in Accounting, Finance, or related field (CPA or CMA designation is preferred).
- Minimum of 5 years of experience in accounting or finance, with at least 2 years in a managerial or supervisory role.
- Strong knowledge of accounting principles, financial reporting, and budgeting.
